County road overlay paving

Two limited areas of Tillamook County roads will be paved this spring.

The first, a one-mile segment of Sandlake Road starting at the junction with Galloway Road and heading toward Tierra Del Mar will be overlaid by the Federal Highways contractor as completion work related to the Sandlake-Galloway Road project.

The second, Long Prairie Road between U.S. 101 and the railroad tracks at Blimp Boulevard will receive an overlay by county workers with funding remaining in the current year budget. The selection of Long Prairie Road to receive this work is the result of discussion and recommendation of the County Road Advisory Committee earlier this war.

The first 800 feet of Long Prairie, east from U.S.101, will only be patched because an Oregon Transportation Act (OTIA) funded project, currently under design, will add a lane and rebuild that part of the road. Work on the OTIA project is planned to begin this fall.

The regular summer paving program of about 4 miles will begin in July.

PL 106-393 factoid

Rather than going for the whole ball of wax in a tumul-tuous election year, U.S. Senator Gordon Smith has proposed a one-year extension of PL, 106-393. If passed, reauthorization would be debated next year,
