

CHAINS

RESTORED CORNERS FOR OREGON STATE BOARD OF FORESTRY

One Quarter corner common to Sections 19 and 20,
T3S, R9W, W.M., Tillamook County, Oregon.

ORIGINAL

No evidence of original corner found.

RESTORED in 1888 (probably by County Surveyor)

Post (found point of post in place) from which a:

22" Fir bears N48°E 24 lks.; now 36" stump scribes BT remaining (bearing is N57°E).

20" Hemlock bears N36°W 49 lks.; now 36" burned out stump, bottom of face remaining.

RESTORED

Set 1½" x 36" galvanized iron pipe with 3" bronze cap marked "OREGON STATE BOARD OF FORESTRY 1/4 S19 S20 1961 RE2311", 32 inches in ground, and from which a:

26" Hemlock bears S72°W 9.2 ft.; scribed 1/4 S19 BT RE2311.

10" Fir bears S6°E 28.8 ft.; scribed 1/4 S20 BT.

Oregon State Board of Forestry metal location poster on 10" Fir BT.
Set 4" x 4" x 72" white painted Cedar post 1 foot SW of corner pipe.
1" pipe 28" above the ground bears N80°W 4.0 ft. Corner is located in a barbed wire East and West fence line.

One Quarter corner common to Sections 17 and 20,
T3S, R9W, W.M., Tillamook County, Oregon.

ORIGINAL

No evidence of original corner found.

RESTORED in 1887 (Probably County Surveyor)

Post from which a:

5" Alder bears South 3 lks.; now missing.

4" Vine Maple bears N75W 8 lks.; now missing.

RESTORED in 1905 (Probably County Surveyor)

Post (now missing) from which a:

10" Alder bears N32-30W 12 lks.; now 16", bark scribes 1/4 S17 remaining.

16" Alder bears S42°E 27 lks.; now 22", bark scribes 1/4 S20.

RESTORED

Set 1½" x 36" galvanized iron pipe with 3" bronze cap marked "OREGON STATE BOARD OF FORESTRY 1/4 S17 S20 1961 RE2311", 30 inches in ground, and from which a:

23" Alder bears North 27.0 ft.; scribed RE2311.

Bark scribed BT on above 2 1905 BT's.

Oregon State Board of Forestry metal location poster on original 16" Alder BT.

Set 4" x 4" x 72" white painted Cedar post 1 foot NE of corner pipe.
