

# County Surveyor's Record, Tillamook County, Oregon

RESTORED CORNER FOR STATE OF OREGON--DEPARTMENT OF FORESTRY

One quarter corner common to Sections 8 and 9, Township 3 North, Range 10 West, Willamette Meridian, Tillamook County, Oregon

CHAINS

ORIGINAL

Post, missing, from which a:

28" Hemlock bears N31 $\frac{1}{2}$ W 14 lks.; now badly rotted stub 18" high, face and scribes rotted away (see note below).

6" Hemlock bears S39E 8 lks.; now missing.

Note: Found metal location poster on 12" uprooted Hemlock 7' South of corner set Aug. 24, 1954 by Vose and McDaniels. This post and a portion of scribe on the N.W. bearing tree was found by S. N. Wells, May 15, 1956. (See Affidavit)

VAR 21 $\frac{1}{2}$  E

Set 1 $\frac{1}{2}$ " x 36" galvanized iron pipe with 3" bronze cap marked "OREGON STATE BOARD OF FORESTRY  $\frac{1}{4}$  S8 S9 1966 RS707" 32 inches in ground, in mound of rock, and from which a:

31" Cedar stump bears N31 $\frac{1}{2}$ E 61.2 ft.; scribed  $\frac{1}{4}$ S9 BT.

48" Cedar stump bears S38 $\frac{1}{2}$ W 71.5 ft.; scribed  $\frac{1}{4}$ S8 BT RS 707.

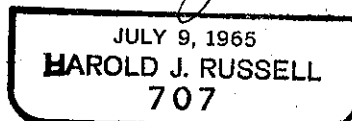
Set 4" x 4" x 60" white painted Cedar post 1.0 ft. N.W. of cornerpipe. Oregon State Forestry Department metal location poster on 48" Cedar stump BT.

AFFIDAVIT

State of Oregon  
County of Tillamook

I Stuart N. Wells, Jr. of Tillamook, Oregon, being first duly sworn, do depose and say as follows:

I am 38 years of age and have worked for the Oregon State Forestry Department for the last 15 years. I saw the one quarter corner common to sections 8 and 9, T. 3N., R. 10W.WM in May of 1956. At that time there was one bearing tree remaining with a portion of scribe remaining on it. It was a dead hemlock stub that beared North  $31\frac{1}{2}^{\circ}$  west 9.2 feet from the corner point which I determined from a copy of the original survey notes. I found a metal location poster on a 12" hemlock that beared south 7 feet from the corner point.
