

Dependent Resurvey, Portion of Subdivisional Lines, T. 4 S., R. 7 W.

CHAINS

undergrowth, vine maple, salal, devil's club, huckleberry, willow, fern and nettle.

From the cor. of secs. 5, 6, 7, and 8, monumented with the original basalt stone, 18 x 10 x 8 ins., loosely set 4 ins. in the ground, mkd. with 1 notch on N., and 5 notches on E. edge.

At the corner point.

Set an iron post, 28 ins. long, $2\frac{1}{2}$ ins. diam., 24 ins. in the ground, with brass cap mkd.

An alder, 25 ins. diam., bears N. $88\frac{1}{4}^{\circ}$ E., 116 lks. dist., bark scribed T4S R7W S5 BT.

A fir, 15 ins. diam., bears S. 17° E., $111\frac{1}{2}$ lks. dist., mkd. T4S R7W S8 BT.

A fir, 29 ins. diam., bears S. 81° W., $35\frac{1}{2}$ lks. dist., mkd. T4S R7W S7 BT.

A fir, 11 ins. diam., bears N. $76\frac{3}{4}^{\circ}$ W., $21\frac{1}{2}$ lks. dist., mkd. T4S R7W S6 BT.

Deposit the original stone alongside the iron post.

N. $89^{\circ} 39'$ W., bet. secs. 6 and 7.

Descend 170 ft. over NW. slope, through heavy timber and light undergrowth.

6.70 Creek, 3 lks. wide, course NW.; asc. 20 ft. over broken NE. slope.

9.60 Top of ascent, slopes N.; desc. 50 ft. over NW. slope.

13.00 Enter creek bottom, edge bears N. 80° E. and S. 80° W.; desc. 15 ft. along old creek channel.

19.79 Point for the E $1/16$ sec. cor. of secs. 6 and 7.

Set an iron post, 28 ins. long, $2\frac{1}{2}$ ins. diam., 22 ins. in the ground, in rocky creek bed, and in a mound of stone, 3 ft. base, to top, with brass cap mkd.

A fir, 33 ins. diam., bears S. 31° W., $85\frac{1}{2}$ lks. dist., mkd. E1/16 S7 BT.

Descend 30 ft. along old creek channel.
