| 55.60 | Top of ascent, slopes N.; desc. 148 ft. over steep W. slope. |
| 58.70 | Ravine, drains N. 20° W.; asc. 7 ft. along broken N. slope. |
| 71.50 | Creek, 8 lks. wide, course NE.; asc. 153 ft. over E. slope, changing to SE. slope. |
| 77.20 | Branch, 1 lk. wide, course SE.; asc. 127 ft. over E. slope. |
| 81.96 | The cor. of secs. 11 and 14, on the E. bdy. of sec. 15. Land, mountainous. Soil, rocky clay with numerous rock outcroppings. Timber, spruce, hemlock, alder, fir, and cedar; undergrowth, salmon-berry, devil's-club, vine maple, and reproduction. |

| 2.85 | Branch, 1 lk. wide, course S. 80° E.; asc. 12 ft. over S. slope. |
| 3.34 | Point for the cor. of secs. 10 and 15, on the W. bdy. of sec. 11, at proportionate distance in latitude and at record distance in departure from the cor. of secs. 9, 10, 15, and 16; there is no remaining evidence of the original corner. Set an iron post, 28 ins. long, $2\frac{1}{2}$ ins. diam., 24 ins. in the ground, with brass cap mkd. |
