RESTORED CORNER FOR STATE OF OREGON--DEPARTMENT OF FORESTRY

J.R. One-Quarter corner common to Sections 3 and 10, Township 34 South, Range 7 West, Willamette Meridian, Tillamook County, Oregon.

CHAINS

ORIGINAL

Stone 10" x 10" x 6" (missing, point falls on steep SW slope) from which a:

- 10' Creek, SW, bears East 1.70 lks.; in place, now bears S 45° W.
- 10' Creek, NW, bears West 1.10 lks.; in place, now bears N 30° W.

RESTORED

Var 21½ E

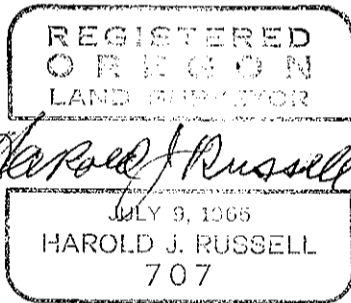
Set 1½" x 36" galvanized iron pipe with 3" bronze cap marked "OREGON STATE BOARD OF FORESTRY 1/4 S3 S10 1968 RS 707", 30 inches in ground, in mound of rock, and from which a:

- 28" Fir bears N75½E 22.2 ft.; scribed 1/4 S3 BT RS 707.
- 28" Fir bears S 78½ E 42.0 ft.; scribed 1/4 S10 BT.
- Spur Ridge, slopes South, bears East 31 ft.;

Set 4" x 4" x 48" white painted Cedar post 1.0 ft. NE of corner pipe. Oregon State Forestry Department metal location posted on SE Fir BT.

One-Quarter corner for Section 33, (South boundary),  
Township 1 North, Range 9 West, Willamette Meridian,  
Tillamook County, Oregon.

CHAINS

ORIGINAL

No evidence of orig. Corner found.

REESTABLISHED by U. S. Cadastral Engineers in 1959

2" Cadastral pipe and cap (now missing, point falls in slide area)  
from which as:

14" Spruce bears N 62 E 63.5 lks. now 17", face and scribes  
1/4 S33 BT partially grown over.

22" Spruce bears N 81 W 124 lks. now 22", face and scribes  
1/4 S33 BT partially grown over.

RESTORED

Var 21 1/2 E

Set 1 1/2" x 36" galvanized iron pipe with 3" bronze cap marked "OREGON  
STATE BOARD OF FORESTRY 1/4 S33 1968 RS 767", 31 inches in  
ground in mound of rock.

Set 4" x 4" x 72" white painted Cedar post 1.0 ft. NE of corner pipe.  
BIM posters on both bearing trees.
