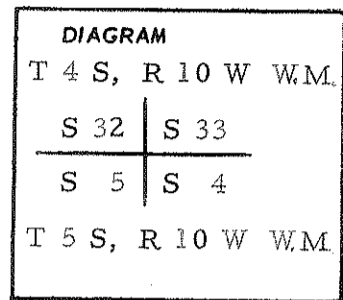


County Surveyor's Record, Tillamook County, Oregon

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner established in 1872 by General Land Office
(Contract Survey)



Old 1872 Bearing Trees are:

- 5" Willow N 40° W 69.30'
- 5" Spruce N 20° E 44.22'
- 4" Spruce S 50° W 19.80'
- 14" Spruce S 55° E 75.90'

Description of corner evidence found:

Found a 2" x 30" iron pipe with a 4" x 4" white cedar post 0.9' east of iron pipe as established by County Survey in 1967 (see County Survey Records). *THIS BOOK PAGE 105 AFD*

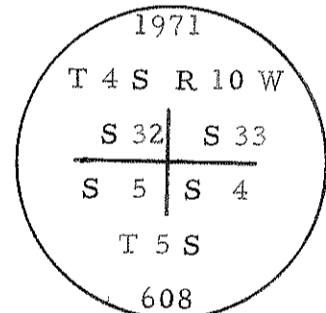
Also found Bearing Trees established in 1967 recorded as follows:

- 16" Spruce S 69° E 25.02' scribed "T 5 S R 10 W S 4 BTCS"
- 24" Fir N 40° 15' E 59.57' @ 15° 0' scribed "T 4 S R 10 W S 33 BTCS"
- 14" Spruce N 63° W 51.42' scribed "T 4 S R 10 W S 32 BTCS"
- 14" Hemlock S 29° 30' W 70.25' @ 17° 0' scribed "T 5 S R 10 W S 5 BTCS"

Description of monument and accessories I established to perpetuate the original location of this corner

At the position of the 2" x 30" iron pipe, placed a 2" x 30" galvanized iron pipe, flared at the bottom and brass cap riveted on the top and extends 3" above the ground.

Set 2" iron pipe along side (Stamped the disk →



From the pipe monument, the Bearing Trees are found to be:

- 22" Spruce S 69° E 26.10' scribed "T 5 S R 10 W S 4 BTCS"
- 24" Fir N 40° 15' E 58.50' scribed "T 4 S R 10 W S 33 BTCS"
- 18" Spruce N 63° W 52.10' scribed "T 4 S R 10 W S 32 BTCS"
- 16" Hemlock S 29° 30' W 67.50' scribed "T 5 S R 10 W S 5 BTCS"

Placed a USFS Bearing Tree sign on each of the four trees at breast high and facing monument.
