

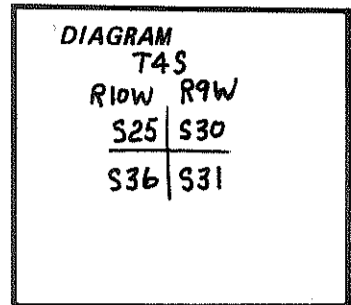
CERTIFIED RECORD OF LAND CORNER MONUMENTATIO.

History of original corner establishment:

Corner established by Henry Meldrum, Deputy Surveyor, under contract No. 301, dated Sept. 13, 1878. Original survey states:

Set fir post, 5 ft. long, 4 ins. sq., for corner to Secs. 25, 36, 30 and 31; from which:

- A fir, 60 inches in diam., bears N45°E, 78 lks.
- A fir, 30 inches in diam., bears N72°W, 183 lks. dist.
- A fir, 40 inches in diam., bears S20°W, 195 lks. dist.
- An alder, 6 inches in diam., bears S40°E, 112 lks. dist.



M. Whitmore, Deputy Surveyor, Tillamook Co., perpetuated and recorded this corner on Oct. 10, 1957.

Description of corner evidence found:

4"x4" post with tapered top 1.5 ft. above ground, scribed with sections on each side, set by M. Whitmore 10 Oct. 1957.

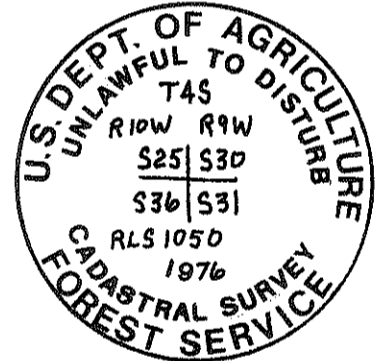
- 60" snag (original B.T.) 15 ft. tall, N45°E, 51.5 ft., scribing gone.
- 30" alder, S44°E, 40.0 ft. bark scribed: T4S, R9W, S31 BT, done by M. Whitmore.
- 36" fir, N31°E, 22.0 ft., healed scribe, done by M. Whitmore, 10 Oct. 1957.
- 22" fir, N17°W, 21.5 ft., healed scribe, done by M. Whitmore, 10 Oct. 1957.
- 42" fork top fir, S57°W, 101.0 ft., healed scribe, done by M. Whitmore.

M. Whitmore, Oct. 10, 1957, found NE BT with scribe marks gone.
NW BT with old axe marks.

Description of monument and accessories established to perpetuate the original location of this corner:

Set a 30" X 3" diameter aluminum cap 0.6 ft. above ground.
Mkd:

Cap information is also stamped at the base of the cap post.
Cap is "break-away" with magnet in top and at base.



- Painted 6" bands around B.T.'s with red paint.
- Attached new B.T. tags.
- Attention signs on back side of B.T.'s
- Placed attention sign on small tree 3 ft south of corner.
