STUMP, SCRIBE "C" REMAINING ON BURNT FACE. (NOW GONE, IN OPEN FIELD).

(BOOK 7 PAGE 318) 25" CEDAR N.6°W. 48.3 FT. (NOW WIND THROWN AND BURIED IN RIVER SILT,  
ROOT HOLE AT POSITION.

(BOOK 7 PAGE 318) 9" ALDER S.50°E. 27.4 FT. (FOUND, NOW 15" ALDER, LEANS APPROXIMATELY 45°  
TO THE NORTH. THE BASE IS AT APPROXIMATE POSITION).

(BOOK 7 PAGE 318) 4"X 4"X 60" WHITE PAINTED CEDAR POST 1.0 FT. NW. (NOW GONE).

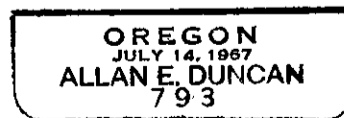
