The right of way 60 ft. in width being 35 ft. on the north, 25 ft. on the south, and parallel to the above described survey.




**RIGHT OF WAY MAP,


Near the East Side of the West 1/2 of the NE 1/4 of Sec. 6, T. 15, R. 9W.

Location of railroad from Sta. 159+36.0 to Sta. 249+48.4: Beginning at Sta. 159+36.0 a point 52.1 ft. north of the N-E Cor. of D.L.C. No 37; thence running 2807.4 ft. N-86°-43'-45"-E to Sta. 187+43.4 the P.C. of a 2° curve to the left; thence following said curve 1780.2 ft. to Sta. 205+23.2 the P.T.; thence running 1102.2 ft. N-51°-07'-25"-E. to Sta. 216+26 the P.C. of a 3° curve to the left; thence following said curve 996.2 ft. to Sta. 226+22.2 the P.T.; Thence running 388.2 ft. N-21°-13'-25"-E to Sta. 230+11.5 the P.C. of a 2°30' curve to the right; thence following said curve 1936.2 ft. to Sta. 249+48.4 a point 6.9 ft. south of the N-E Cor. Sec. 6. T. 1-S. R. 9-W.

The right of way 60 ft. in width being 35 ft. on the north, 25 ft. on the south, and parallel to the above described survey.

The west end of said right of way entering the B.H.Hathaway property at Sta 159+36.0, the east line of the Hiram Smith D.L.C. No 45 and leaves the same at the intersection of the section line between Sec. 6. T. 1-S. R. 9-W. and Sec. 1. T. 1-S. R. 10-W. at Sta. 181+78.2




B. H. HATHAWAY PROPERTY**




**RIGHT OF WAY MAP

The west end of said right of way entering the Warren B. Vaughn property at the intersection of the county road, about Sta. 225+55 and leaves the same at the intersection of the section line between sections 5 & 6. T. 1-S. R. 9-W.



N-51°-07'-25"-E to Sta. 215+425 the P.C. of a 3° curve to the left; thence following said curve 1090± ft. to Sta. 226+325 the P.T.; thence running 414± ft. 
**RIGHT OF WAY MAP
