KNOW ALL MEN BY THESE PRESENTS, that the UNION CEMETERY ASSOCIATION OF TILLAMOOK COUNTY, OREGON, in consideration of one dollar and other valuable considerations to us paid by CLO-VERDALE BOPTIST CHURCH of Cloverdale, Oregon, imas successors and assighms, to have and to hold forever, the following described real property to be used for a cemetery, situated in Tillamook County, Oregon:

Beginning at the N.W. corner of the N.E. of the S.W. of Section 33, Township 4 South, Range 10 West, Williamette Meridian; thenceSouth 89 degrees 15 min. E. 386.4 feet; thence S. 4 degrees 25 min.W. 285.8 feet; thence N. 85 degrees 35 min. W. 255.9 feet; thence N. 4 degrees 25 min. E. 249.6 feet; thence N. 89 degrees 15 min. W. 130.0 feet; thence N. 20.0 feet; to place of beginning. Less that portion taken by the County Road and Highway 101, which is a strip 50 wide and 256.4 feet long, along the North side of cemetery and a strip 20 feet wide and 130.0 feet long, extending westward from afore mentioned strip to the place of beginning, leaving a tract of 1.3 acres, more or less, in the cemetery.


