AFFIDAVIT

State of Oregon Tillamook, county

I, Harold Williams, of Bay City, Oregon, being first duly sworn, do depose and say as follows:

I am fifty-seven years old and have been a timber comiser for the last thirty-five years. I saw the one quarter corner common to sections 25 and 26 T.2S. R.9W.W.M. in 1918, 1919, 1925, 1927, 1933 and 1934 while working for the Whitney Co. Ltd. and the Dye and Riechers Logging Co. With a copy of the original notes I found a cedar bearing tree with scribes visible. It was destroyed by logging in 1938. I also saw a large spruce, which was approximately 30 feet north of the corner point, with evidence of two old faces on it, which now is a stump with old axe work on it. Richard Morris placed a 1½ x36" galvinized iron pipe with a 3" bronze cap, furnished by the Oregon State Board of Forestry, at the point where the original corner set.
