

## Dependent Resurvey of Base Line, Portion of S. Bdy. of T. 1 N., R. 8 W.

Chains	Ascend 98 ft. over E. slope, in the Tillamook Burn through young alders and dense undergrowth.
2.00	Spur, slopes N. 20° E.; desc. 88 ft. over steep NW. slope.
4.575	Find no evidence of Sharp's closing corner of secs. 5 and 6 on the N. bdy. of T. 1 S., R. 8 W.
	Descend 123 ft. over NW. slope.
9.06	Branch, 2 lks. wide, course NE.; asc. 650 ft. over steep, rocky E. slope, changing to NE. slope.
25.10	Skid road, bears NE. and SW.
26.26	Ridge, bears N. and S.; desc. 272 ft. over W. slope, changing to NW. slope.
31.73	Abandoned logging road, 15 lks. wide, bears N. and S. 30° W.
36.86	Point for the $\frac{1}{2}$ sec. cor. of sec. 31 only, at proportionate distance; there is no remaining evidence of the original corner established by Moldrum.  Set an iron post, 28 ins. long, $2\frac{1}{2}$ ins. diam., 24 ins. in the ground, with brass cap and.

	A hemlock, 30 ins. diam., bears N. $30\frac{1}{2}$ ° E., 170 lks. dist., mid. $\frac{1}{2}$ S31 BT.
	An alder, 9 ins. diam., bears N. 47° W., 76 lks. dist., bark scribed $\frac{1}{2}$ S31 BT.
	From this point the original Snowden $\frac{1}{2}$ sec. cor. of secs. 6 and 31, R. 8 W., Willamette Base Line, bears S. $86^{\circ} 15'$ W., 2.934 cha. distance, perpetuated with an iron pipe, 2 ins. diam., protruding 8 ins. above ground, firmly set, in a mound of stone, 3 ft. base, to top, at record bearing and distance from the remaining original bearing tree:
	A hemlock stub, 36 ins. diam., bears S. 37° W., 37 lks. dist., with scribe marks $\frac{1}{2}$ S visible on rotted and opened blaze.
	and trees marked by the Oregon State Board of Forestry in 1958:
	An alder, 7 ins. diam., bears N. 32° E., 92 lks. dist., bark scribed $\frac{1}{2}$ S31 BT.
	An alder, 7 ins. diam., bears N. $54\frac{1}{2}$ ° W., 104 lks. dist., bark scribed $\frac{1}{2}$ S31 BT RS401.
	This corner was not recovered by Moldrum, was superseded by his Base Line as a basis for the plats of adjacent townships, and is not rehabilitated.
	Descend 464 ft. over NW. slope, changing to steep SW. slope.
49.93	Branch, 1 lk. wide, course SW.; asc. 100 ft. over SW. slope.
