A fir, 48 ins. diam., Brs. S57°W 66 1ks. dist. A fir, 30 ins. diam., Brs. N17°E 83 1ks. dist.

Corner is common to Sec. 12 only because of a closing corner T4S, R9W, to Sec. 7 and 18 set by Charles E. Branson, Deputy Surveyor, contract No. 687, June 8, 1898.

M. Whitmore, Deputy Surveyor, Tillamook Co., perpetuated this corner on Jan. 4, 1953.

Description of corner evidence found:

Pitch slab set by M. Whitmore, Jan. 4, 1953.

12" fir, brs. N76°W, 9.6 ft. with healed scribe, set by M. Whitmore Jan. 4, 1953. Top of BT broken off 25 ft. above the ground. Blazed "X" on BT.

18" fir, brs. S13°W, 8.0 ft., forked top, blazed "X" on BT. Set by L. Whitmore, Feb. 25, 1970.

48" fir snag, brs. 857°W, 43.3 ft., 15 ft. tall, no visible scribing. Set by GLO 1879. M. Whitmore saw scribe marks on the original witnesses in 1953.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 30"x2-1/2" diam. aluminum pipe 6 ins. above ground with a 3" diam. cap mkd., set pitch slab by cap.

Cap information is also stamped at the base of the cap post. Cap has a magnet in the top and in the break away base.

New B.T.:

12" fir, N44°W, 14.4 ft., scribed: "BT" nailed brass washer, stamped "LS 1050" at base of B.T., blazed an "X" at breast height on B.T.

Painted red 6" band around B.T.'s. Attached attention signs on back side of B.T.'s.

Set  $6^{\prime\prime}$  fence post with attention sign attached 4' south of corner. Posted BT tags.
