- 6) Hovden also blazed and scribed, "T4N R6W S 36 CSBT" (I set an 8d nail* between the "6" and "W"), a 16" diameter Fir tree, N 72°14' W, 40.67 feet. He also nailed a 4 1/4" x 5" aluminum tag, marked "CLATSOP CO. SURVEYOR T4N R6W SEC 36 TACK ON SECTION DIAGRAM SHOWS LOCATION", to said tree;
- 7) Found the northwest, 1892, Government Bearing Tree, "a fir 40 ins diam bears N 73° W 20 lks dist Marked T4N R6W S 36 BT", now a 40" diameter, rotting stump (had been a windfall now leans about 10° to the east), N 67°54' W, 13.20 feet to a tack set just below "chaining notch". A small blaze was found 0.4 feet below tack. In the debris at the base of this stump, found top portion of blaze, but no scribes;
- 8) Set an 8d nail*, 0.5 feet above the ground, in a 13" diameter Alder tree, N 10° 02' E, 13.45 feet. A 4 1/2" x 5" yellow tag, marked "OREGON STATE BOARD OF FORESTRY SEC 36 & 31 T4NR5&6W TWN SHP COR 16.0 FT SOUTH TACK INDICATES LOCATION OF POSTER A.G. JM 8/11/5, was found nailed to this tree;
- 9) Found the northeast, 1892, Government Bearing Tree, "a fir 24 ins diam bears N 52° E 20 lks dist marked T4N R5W S 31 B.T.", now a 22" diameter (plus bark), badly rotted stump, N 45°57' E, 13.08 feet to a 8d nail* set in the sap wood. In the debris at the base of this stump, found evidence of axe work;
- 10) P.F. Dewey, Columbia County Surveyor, blazed and scribed, T4N R5W S 31 CSBT (set tack* between "5" and "W", 3.5 feet above the ground), a 19" diameter Fir tree, N 51°04' E, 59.61 feet;
- 11) R. Charles Pearson, Washington County Surveyor, blazed and scribed, T3N R5W S 6 CSBT, (set tack* below "6", 1.5 feet above the ground), a 16" diameter Fir tree, S 65°11' E, 71.57 feet (71.6 feet to notch);
- 12) Found a 2 3/4" diameter brass disk, marked 36 31 TPS 3 & 4N RGS 5 & 6 WM OSHD COR", setting in concrete, as set Survey 1 6 no. 3231, S 40°55' E, 3.98 feet; and
- 13) Set a 6 foot long, galvanized steel post, 3.5 feet high, 2.0 feet north. A 6" x 10" aluminum paddle, marked "WASHINGTON COUNTY MONUMENT 4N6 36 31 4N5 UNLAW-FUL TO DISTURB NOTIFY COUNTY SURVEYOR", was attached to 3N6 1 6 3N5 said post. Hovden set a 2 1/2" wide x 6 foot long, white plastic post, 3.5 feet high, 5.0 feet north. Post marked "WITNESS POST PLEASE DO NOT DISTURB NEARBY SURVEY MARKER".
- * Bearing and distance are to head of nail or tack.
