History of found monument

This corner is not in the correct location for the Center of the Section. according to a recent survey by the Dregon Department of Forestry, which retraced the East line of the Section (T.C.S. Map A-6301) and found it to be very different from Andersons, (T.C.S. Map A-379), but was rewitnessed by this office for its historical value.
