50.60 to a point from which the corner as established for corner to Townships 3&4 North, Ranges 6&7 West [See Record No. 1] ... After destroying all marks on bearing trees and stake which refer to sections 31 and 6.

73.85 the closing corner to Townships 3 and 4 North Range 6 West which is marked by a hemlock 6 ins diam. ... from which:

A 14" Hemlock bears N47°30'E, 32 lks. (21.12'); A 5" Hemlock bears S17°E, 59 lks. (38.94'); An 8" Hemlock bears N62°30'W, 69 lks. (45.54').

Record No. 4


