

SECTION CORNER COMMON TO SECTIONS 1 AND 12, T.2N., R.7W., W.M.



I FOUND A MOUND OF STONES WITH REMAINS OF VERY ROTTEN WOOD STAKE IN CENTER. I REPLACED THE FOUND STAKE WITH A 1 1/2" IRON PIPE AND 3" TILLAMOOK COUNTY SURVEYORS BRASS CAP AND ENCASED IN MOUND OF STONES AND CONCRETE.

I FOUND THE FOLLOWING ACCESSORY EVIDENCE OF THIS CORNER

(ORIGINAL G.L.D.) 18" HEMLOCK S.68°W. 47 LINKS; (FOUND, NOW A 23" HEMLOCK STUMP, SCRIBING VISIBLE, S.60°W 31.5" TO FACE).

(ORIGINAL G.L.D.) 18" HEMLOCK N.20°W. 61 LINKS; (FOUND, NOW A VERY ROTTEN 20" HEMLOCK STUB, SCRIBING VISIBLE, N.17°W 44.5' TO FACE. LOCATED ON NORTH SIDE OF LARGE ROCK OUT CROPPING).

(ORIGINAL G.L.D.) 36° FIR N.22°E. 34 LINKS; (FOUND, NOW A 36°, LOW CUT FIR STUMP, BOTTOM OF FACE VISIBLE, N.22°E 22.4° TO FACE, FOUND, FADED YELLOW METAL LOCATION POSTER INSCRIBED BERT MASON JR. 10-1956 ATTACHED).

(DRIGINAL G.L.D.) 24" FIR S.14°E. 54 LINKS; (FOUND, NOW A 38" FIR STUMP, SCRIBING VISIBLE, S.15°E 37.6' TO FACE).

(DRIGINAL G.L.D.) 48' FIR LINE TREE SDUTH 1.25 CHAINS; (FOUND, NOW A 67' FIR STUMP, POSSIBLE OVERGROWN NOTCH ON SOUTH SIDE, SOUTH 81 FEET TO CENTER OF STUMP).

*24" HEMLDCK S.60°W. 16.20", SCRIBED "T2NR7WS12BTCS". THE DISTANCE WAS MEASURED TO A NAIL WITH BRASS WASHER, INSCRIBED "T.C. SURVEY", IN THE FACE BETWEEN THE B & T.

*72' LIGHT HAT SECTION POST IN THE CENTER OF THE ORIGINAL BEARING TREE N.22'E. 23.2'.
