

HISTORY OF FOUND MONUMENT

I FOUND THIS MONUMENT TO BE AS DESCRIBED ON T.C.S. MAP #B-404 AND THE REFERENCES SET AT THAT TIME TO NOW BE AS FOLLOWS:

*(B-404) 6' CEDAR S.34 1/2'W. 148.9'; (FOUND, NOW A 28' CEDAR, FACE HEALED, AT POSITION).

(B-404) 6' SPRUCE S.66 1/2'E. 120.0') (FDUND, NDW A 36' SPRUCE STUMP, 2' TALL, FACE HEALED, LOG IS LAYING SOUTH OF THE STUMP, AT POSITION, BEES NEST BEARS NORTH 30').

(REWITNESS BOOK 1 PAGE 377) 4"X 4"X 56" W.P.C.P. 1.0" NW OF PIPE, (FOUND, AT POSITION).
