

RESTORED CORNER FOR OREGON DEPARTMENT OF FORESTRY
4907 Third St., Tillamook, Oregon 97141

Witness Corner to Sections 8, 9, 16 and 17, T2N, R7W, W.M.,
Tillamook County, Oregon.

ORIGINAL by Henry Meldrum, September 14, 1891.
17"x12"x6" basalt stone; missing.

- 18" Hemlock bears N62°E 52 lks.; missing.
- 24" Hemlock bears S60°E 60 lks.; missing.
- 5" Hemlock bears S50°W 60 lks.; missing.
- 18" Hemlock bears N34°W 41 lks.; now a 20"x7 foot high badly
rotted stump with axe work visible on apparent face.

NOTE: Book 1, Page 277, Tillamook County Records, Bert Mason, Jr.
November 20, 1956 reports finding "A stone with 4 grooves on the
South side, a 6" squared post and two old BT's, none of which
comply with the original notes. I check the calls in all four
directions... the calls leading out of this corner to the North check
the ground and match distances scaled from the plat of 1893, but do
not check with the plat of 1891."


December 5, 1956 Mason reports "At the corner to Sections 8, 9, 16
& 17, T2N, R7W I find a blazed tree agreeing with in age, size and
direction of blaze with the original notes. The marks have been
chopped away. I check the calls to the South and East from this
point and the measurements also check measurements scaled from the
plat of 1891. But they do not check the plat of 1893."

RESTORATION by Bert Mason, Jr., LS322, December 5, 1956 (Book 1,
page 277, Tillamook County Records).

From Meldrums NW BT Mason sets an unmarked 1½"x30" galvanized
iron pipe 20" in ground, 55.1 ft. South of the true corner
point, said point falling in a logging road; now 10" above
ground and leaning out of place.

- 42" Hemlock stump bears S12°E 40.6 ft.; now 5½ foot high and
badly rotted with no face visible.
- 50" Fir stump bears S47°W 58.0 ft.; now 5 foot high and
rotted with scribes S17BTL322 visible.
- 39" Fir stump bears N62°W 45.3 ft.; now 4 foot high and
badly rotted with portions of scribes visible.

Var. $18\frac{1}{2}^{\circ}$ E

Set a $1\frac{1}{2}$ " x 40" galvanized iron pipe with 3 3/4" bronze cap marked "T2NR7WWC55.1FT S8S9S17S162000LS1998", 36" in ground, in mound of stone and placed Mason's pipe alongside, 55.1 ft. South of true corner point. From which a:

- 19" Fir bears $N44\frac{1}{2}^{\circ}$ E 59.3 ft. to face; scribed WCT2NR7WS9BT.
- 15" Hemlock bears $S08\frac{1}{2}^{\circ}$ E 35.6 ft. to face; scribed WCT2NR7WS16BT.
- 21" Noble Fir bears $S69\frac{1}{2}^{\circ}$ W 22.45 ft. to face; scribed WCT2NR7WS17BT.
- 20" Fir bears $N62\frac{1}{2}^{\circ}$ W 35.15 ft. to face; scribed WCT2NR7WS8BT.

Metal location poster on new BTs. Also on Mason's 50" Fir BT.

3/4" brass washer marked "LS1998" nailed to face of new BTs.


6 foot orange Carsonite post bears $S40^{\circ}$ W 1.9 ft.

Centerline of old logging road bears North 31.5 ft. course $S55^{\circ}$ E by $N38^{\circ}$ W.
