ONE-QUARTER CORNER COMMON TO SECTIONS 8 AND 9, TOWNSHIP 1 NORTH, RANGE 7 WEST, WILLAMETTE MERIDIAN, TILLAMOOK COUNTY, OREGON.

I FOUND A 3" DIAMETER BRASS CAP STAMPED AS SHOWN HEREON, DISTURBED BY HIGHWAY CONSTRUCTION AND LEANING NORTH. I REESTABLISHED THE MONUMENT BY HOLDING THE RECORD BEARING AND DISTANCE FROM THE FOUND 15" DIAMETER, 5.5 FEET TALL BEARING TREE AND THE RECORD COORDINATES CONTAINED ON INSTRUMENT NUMBER 2003-425185. I THEN ENCASED THE MONUMENT IN CONCRETE. THIS CORNER IS ALSO DESIGNATED AS AN NGS ELEVATION BENCHMARK C283 1939. THIS RESTORATION DOES NOT REESTABLISH THE VERTICAL POSITION OF THE BENCHMARK. THE PUBLISHED ELEVATION IS NO LONGER VALID.
