I FOUND A 3" DIAMETER BRASS CAP IN GOOD CONDITION STAMPED AS SHOWN HEREON. THE MONUMENT IS APPROXIMATELY 1 FOOT BELOW THE GROUND SURFACE. I ENCASED THE MONUMENT IN A CONCRETE CYLINDER.



HISTORY OF FOUND MONUMENT

THIS MONUMENT WAS ORIGINALLY SET BY THE GENERAL LAND OFFICE BY S. SNOWDEN IN AUGUST OF 1857. THE CORNER WAS THEN REESTABLISHED BY RICHARD A. MORRIS, L.S. 401 IN FEBRUARY OF 1959. RICHARD A. MORRIS FOUND NO EVIDENCE OF THE ORIGINAL CORNER. AN AFFIDAVIT WAS OBTAINED FROM HAROLD WILLIAMS, A TIMBER CRUISER, WHO TESTIFIED THAT HE WAS A WITNESS AS TO THE LOCATION OF THE ORIGINAL CORNER. THE MORRIS REESTABLISHMENT AND THE WILLIAMS AFFIDAVIT ARE FILED IN REWITNESS BOOK 1, PAGE 385, TILLAMOOK COUNTY SURVEY RECORDS.

THE MONUMENT WAS FOUND AS DESCRIBED IN REWITNESS BOOK 1, PAGE 385, AND THE ACCESSORIES FOUND AND/OR SET AT THAT TIME TO NOW BE AS FOLLOWS:


LOCATION OF MONUMENT
