HISTORY OF FOUND MONUMENT

THIS MONUMENT WAS ORIGINALLY SET BY THE GENERAL LAND OFFICE BY HENRY MELDRUM IN JUNE 1884. THE CORNER WAS THEN REESTABLISHED BY RICHARD A. MORRIS, L.S. 401 IN MAY OF 1958.
