
TILLAMOOK COUNTY SURVEYORS OFFICE COURTHOUSE, TILLAMOOK, OREGON 97141

SECTION CORNER COMMON TO SECTIONS 3 AND SECTION 10, TOWNSHIP 2 SOUTH, RANGE 9 WEST, WILLAMETTE MERIDIAN, TILLAMOOK COUNTY, OREGON.

I FOUND A 3" DIAMETER TILLAMOOK COUNTY SURVEYORS BRASS DISK ENCASED IN A 10" DIAMETER TILE WITH CONCRETE. THE MONUMENT WAS FOUND IN GOOD CONDITION AND STAMPED AS SHOWN HEREON. I PLACED ADDITIONAL CONCRETE AROUND THE EXISTING MONUMENT.



HISTORY OF FOUND MONUMENT

SAMUEL D. SNOWDEN SET A POST AND BEARING TREES AT THE CORNER OF SECTIONS 2, 3, 10 AND 11 IN 1857. HENRY MELDRUM, WHILE RESURVEYING A PORTION OF TOWNSHIP 2 SOUTH RANGE 9 WEST IN 1884, FOUND A DECAYED POST. HE ALSO FOUND ALL OF THE BEARING TREES SET IN 1857 STILL STANDING. MELDRUM THEN RESET THE POST FOR THE CORNER TO SECTIONS 3 AND 10. REWITNESS BOOK 4, PAGE 15, SET A SPRUCE STAKE AT THE CORNER COMMON TO SECTIONS 3 AND 10 IN 1904. A 2" IRON PIPE WAS THEN SET AT THE CORNER IN 1965 AT THE LOCATION OF A FOUND OLD AND BROKEN SPRUCE LIMB. A NEW BEARING TREE WAS SET AS AN ACCESSORY TO THE IRON PIPE.

THE CORNER WAS THEN REWITNESSED BY THE TILLAMOOK COUNTY SURVEYORS OFFICE IN 1972. A 2" IRON PIPE WITH BRASS DISK WAS SET IN CONCRETE AND TILE AT THE POSITION OF A FOUND IRON PIPE. THE INFORMATION FOR THIS REWITNESS WAS FILED AS REWITNESS BIN NUMBER 351, TILLAMOOK COUNTY SURVEY RECORDS. THE BEARING TREES SET BY THE G.L.O. AND BY BOOK 4, PAGE 15, WERE NOT FOUND.

IN FEBRUARY OF 2006, THE MONUMENT WAS FOUND AS DESCRIBED ON REWITNESS BIN NUMBER 351, AND THE ACCESSORIES FOUND AND/OR SET AT THAT TIME TO NOW BE AS FOLLOWS:

REWITNESS BIN NUMBER 351 - FOUND A 10" DIAMETER SPRUCE TREE (10" DIAMETER SPRUCE SOUTH 23° WEST 27.45'); 02-22-06 - GONE.

REWITNESS BIN NUMBER 351 - 36" DIAMETER HEMLOCK TREE NORTH 57° WEST 4.78'; 02-22-06 - *FOUND A 7' TALL, 41" DIAMETER STUMP WITH A HEALED FACE AT RECORD POSITION.

REWITNESS BIN NUMBER 351 - 12" DIAMETER SPRUCE TREE SOUTH 21° WEST 27.3'; 02-22-06 - *FOUND A 7' TALL, 23" DIAMETER STUMP WITH A HEALED FACE AT RECORD POSITION.

REWITNESS BIN NUMBER 351 – SET AN 84" HAT SECTION POST WEST 1.5 FEET; 02-22-06 - *FOUND HAT SECTION POST AT RECORD POSITION.
