# TILLAMOOK COUNTY SURVEYORS OFFICE COURTHOUSE, TILLAMOOK, OREGON 97141

SECTION CORNER COMMON TO SECTIONS 15 AND 22, TOWNSHIP 2 SOUTH, RANGE 9 WEST, WILLAMETTE MERIDIAN, TILLAMOOK COUNTY, OREGON.

I FOUND A 3" DIAMETER OREGON STATE BOARD OF FORESTRY BRASS DISK ENCASED IN A 10" DIAMETER TILE WITH CONCRETE. THE MONUMENT WAS FOUND IN GOOD CONDITION AND STAMPED AS SHOWN HEREON. I PLACED A 12" PLASTIC CYLINDER AROUND THE EXISTING MONUMENT AND CONCRETE AND I THEN PLACED 180 POUNDS OF CONCRETE IN THE CYLINDER AND AROUND THE EXISTING MONUMENT.



### HISTORY OF FOUND MONUMENT

SAMUEL D. SNOWDEN, GLO SURVEYOR, SET A POST AND BEARING TREES AT THE CORNER OF SECTIONS 14, 15, 22 AND 23 IN 1857. HENRY MELDRUM, GLO SURVEYOR, WHILE RESURVEYING A PORTION OF TOWNSHIP 2 SOUTH RANGE 9 WEST IN 1884, VISITED THE CORNER TO SECTIONS 15 AND 22. ACCORDING TO REWITNESS BOOK 1, PAGE 320 THIS CORNER WAS RESTORED BY W.E. ANDERSON IN 1925 AND RECORDED IN FIELD BOOK P1, PAGES 122-124 AND 128. THE CORNER WAS THEN RESTORED BY THE OREGON STATE BOARD OF FORESTRY ON APRIL 4, 1958 BY RICHARD A. MORRIS. THE CORNER WAS THEN REWITNESSED BY THE TILLAMOOK COUNTY SURVEYORS OFFICE ON APRIL 23, 1980 BY REWITNESS BIN NUMBER 395.

IN FEBRUARY OF 2006, THE MONUMENT WAS FOUND AS DESCRIBED ON REWITNESS BIN NUMBER 395, AND THE ACCESSORIES FOUND AND/OR SET AT THAT TIME TO NOW BE AS FOLLOWS:

REWITNESS BIN NUMBER 395 - FOUND HEMLOCK STUMP, SCRIBING VISIBLE (38" DIAMETER HEMLOCK TREE NORTH 12-1/2" WEST 73.7"); 02-09-06 - FOUND A 5" TALL HEMLOCK STUMP WITH ROTTED FACE AND NO VISIBLE SCRIBING AT RECORD POSITION.

REWITNESS BIN NUMBER 395 – A 4" DIAMETER FIR TREE SCRIBED "S15 BT" NORTH 22° WEST 4.80'; 02-09-06 -FOUND A 6" DIAMETER FIR TREE WITH A HEALED FACE AT RECORD POSITION.

REWITNESS BIN NUMBER 395 – A 5" DIAMETER HEMLOCK TREE SCRIBED "S22 BT" NORTH 22° WEST 4.80'; 02-09-06 - \*FOUND A 24" DIAMETER HEMLOCK TREE WITH A HEALED FACE AT RECORD POSITION.

REWITNESS BIN NUMBER 395 - FOUND A 4" X 4" X 72" WCPC 1.5' N.E.; (SET A 4" X 4" X 72" WHITE PAINTED CEDAR POST 1.5' NE OF PIPE); 02-09-06 - GONE.
