Found Monument(s) and Accessories (Condition & Source): We first established a position by using the existing centerline monumentation at Third Street and Stillwell Avenue and at Seventh Street and Stillwell Avenue. We then used the control established by C. Wayne Cook, PLS 1098 and used a mean of the two angles to Cook's position and the position established by using the existing centerline monumentation. The mean of the angle right is 324° 35' 47".					
Monument Set (Procedures and Description): The reference markers set by the Tillamook County Surveyor for this centerline-centerline monument were removed by construction of a new sewer manhole. The control for a previous tie to the monument by C. Wayne Cook, PLS 1098 was used to re-establish the position of the monument. The occupy point is a found 'PK' nail in the sidewalk at the Southeast quadrant of the intersection of First Street and Stillwell Avenue. The back sight point is a found 30d nail in the sidewalk on the West side of Stillwell Avenue. The values being North 13° 08' 47" West 215.01'. The bearing and distance to the monument position from the 'PK' nail are North 48° 34' 48" West 46.74'.
