We cut the pipe approximately 12" above ground and proceeded to set the brass cap as detailed below. Original Hemlock tree is now gone. Found a badly rotten Douglas Fir stump (48" diameter with boat spike - Book 1, Page 171) but did not find a boat spike in the tree. The 30" diameter Douglas fir stump (Book 1, Page 171) is now gone. We also found a white painted cedar post South 1.0' from monument.				
Monument Set (Procedures and Description): We set a 3" diameter Tillamook County Surveyor brass cap inside of a found 2-1/2" iron pipe. The cap is stamped as shown hereon.
