Found Monument(s) and Accessories (Condition & Source): Found a 3" Tillamook county brass cap stamped "Tillamook Beach RS 793 1982" set in concrete; inside a water meter box. The monument is flush with the surface and in good condition. The existing water meter box was removed and new concrete was set around the monument.

(Rewitness #19A) – 4" x 4" x 48" wood post located North 0.5' is now gone.

(Rewitness #19A) - Power pole located S10°W 15.14' is now gone.

(Rewitness #19A) - Telephone pole located S86°E 56.37' is now gone.

(Rewitness #19A) - Power Pole anchor located 4' North is now gone.

New accessories set: Power Pole #051618 with nail and Tillamook County Washer stamped "Till. CO. Surveyor" set 16" above ground which bears S 7° 30' W 18.12'. Yellow metal location poster affixed.

Punch in top of valve of fire hydrant which bears N 41° W 21.43'

Found 3" Iron Pipe set 4' above ground with 3/8" Iron Rod in top S79° W105.4'

New Bearing Trees set: No bearing trees were available.

Location & Comments: The found monument was tied by GPS.

The corner is located approximately 30' West of the center of the existing railroad tracks.
