Found Monument(s) and Accessories (Condition & Source) History: In October of 1857 The Section Corner Post was set; a stake was set with a raised mound and a trench. In 1941 W.E Anderson Rewitnessed the corner and set a lead plug with hub tack in the concrete pavement approx. 2 inches below surface. In July, 1950 The corner was Rewitnessed again and new accessories were added. Then in February of 1980 the lead plug and hub tack were replaced with a ½ inch Iron rod and a 3 inch Tillamook County Brass Cap stamped "T1S R10W R9W S25, S30, S36, S31, RS 287 1980"; along with setting new accessories. In 1998 the monument was destroyed during bridge construction; then replaced with a Tillamook County Brass Cap stamped "T1S R10W R9W S25 S30 S36 S31 LS 793 1998" set flush with the surface of the road.

Found Tillamook County Brass Cap stamped "T1S R10W R9W S25 S30 S36 S31 LS 793 1998" Flush with the surface of Tillamook River Loop Rd. See reference on A-7455 Tillamook County Records.
