


Found Monument(s) and Accessories (Condition & Source): In 1857 Samuel Snowden set a wooden post and accessories for the quarter corner common to 17, & 20. In 1856 the quarter corner was reset with a cedar post and two new accessories by A. M. Austin. In 1966 the Tillamook County Surveyors office set a 2" Iron pipe flush with ground in place of the 3"x3"x18" cedar post that was set for the quarter corner and set new accessories. In September of 1973, the Tillamook County Surveyors office set a 2" Iron pipe with 3" Brass cap stamped "N1/4 S17, S20 RS 287 1973" in a 10" tile filled with concrete and set two new accessories. In March of 2003 Terry Jones set a steel fence post 1' East of Monument.

New accessories set: Coordinates given are only for locating monument.

The Found Monument was Tied conventionally using GPS control. WGS 84: Latitude: 45°33'55"N; Longitude: 123°56'9"W. Found: 3" Brass Disk Stamped "INITIAL POINT TERWILLIGER VIEW 1989" set in concrete which bears S50°46'10"W 368.32' per Plat C-398 Tillamook County records; measured grid value of S53°12'16"W 368.36'.

New Bearing Trees set: No bearing trees available.

Location & Comments: Traveling North from downtown Garibaldi ±1.3 miles, turn East on to Harbor View Drive follow for ±.10 of a mile to the intersection of Horizon Ct. and Harbor View Drive the monument is ±406' North on a South facing slope.
