Found Monument(s) and Accessories (Condition & Source): In 1917 the Tillamook County Surveyors office placed an x on a rock in the County Rd. right of way N12°58'E 412.85' from the center quarter corner of Section 27. In 1923 W.S. Coates set a spruce limb for the center quarter of Section 27. In 1931 W.E. Anderson filed a survey B-31 that used the corner to help subdivide the section. The survey did not state whether or not the corner was monumented, Found or Just calculated for position. In 1969 The Tillamook County Surveyors Office started researching the corner which was missing. In 1971 the County Surveyors office recreated old traverses from Field books to set the Center Quarter Corner of Section 27 a 2" Iron Pipe with a 3" Tillamook County Brass Cap Stamped as shown here on, set in concrete surrounded by a clay tile, and set 3 accessories as show hereon. In 2020 the Tillamook County Surveyors Office Found in good condition a 3" Tillamook County Brass Cap in Concrete and surrounded by a clay tile 3" below surface.


